

2026 FORECLOSURE LIST ISSUED BY BAKER COUNTY

THE TAX COLLECTOR of Baker County, Oregon has prepared a list of all real properties in said County now subject to foreclosure for delinquent taxes. This foreclosure list was prepared under and by virtue of the provisions of ORS Chapter 312, Title 30, and contains the names of several persons appearing in the latest tax roll as the respective owners of the tax delinquent properties, a description of each such property as the same appears on the said latest tax roll, the years for which taxes, fees, and other charges are delinquent on each property, together with the principle amount of delinquent taxes each year and the amount of accrued interest thereon through September 15, 2026; that a copy of said list is hereto attached and marked for identification as Exhibit A.

YOU ARE HEREBY REQUIRED to take notice that Baker County has filed in the circuit court of the State of Oregon for Baker County an application for the foreclosure of the lien of all taxes shown on the 2026 Baker County foreclosure list, herein set forth in full and that Baker County as plaintiff will apply to the court for general judgment foreclosing such tax liens not less than thirty (30) days from the date of the publication of this notice.

ANY AND ALL PERSONS owning or claiming to own or claiming to have any legal interest in any of the real property included in the foreclosure list are required to file answer and defense, if any there be, to such Application for Judgment and decree within thirty (30) days from the date of the publication of this notice, which is the 26th day of August 2026.

NOTICE OF THE FORECLOSURE proceeding is given under ORS 312.040(1) by one (1) publication of the foreclosure list in the East Oregonian, a weekly newspaper of general circulation in Baker County, Oregon. This notice is published by authority of an order of the Board of Commissioners of Baker County and designated in said order of the Board of Commissioners as the newspaper in which said notice is to be published, said order being dated August 5, 2026.
