**OWNER WILL MAINTAIN AGREEMENT**

This agreement is not transferable.

I, \_\_\_\_\_, hereby agree to adequately control vegetation (per current Baker County Noxious Weeds list) growing within the Baker County road right-of-way, adjoining my property, in lieu of herbicide applications by County personnel. Determination of "adequate control" is at the sole discretion of County Weed Control or Road Department personnel, but at a minimum will mean the following:

1. That the listed noxious weeds are not producing seed; and,
2. The shoulder is kept vegetation free to allow for water movement off the road surface.
3. Keep all tree limbs pruned back and brush clear of the right-of-way.

I further agree to post "OWNER WILL MAINTAIN" (OWM) signs supplied by the Baker County Road Department in the manner prescribed by Baker County, as follows:

1. "START" and "END" OWM signs must be utilized.
2. Place signs on a stake near the property line facing the direction of oncoming traffic.
3. Keep all weeds, grass, brush, and limbs cut away from OWM signs so that they can be easily seen by maintenance crews.

I further agree to periodically inspect the signs for assurance that they are in place from March 1<sup>st</sup> through November 30<sup>th</sup> of each year. I understand it is my responsibility to replace or repair signs as necessary to ensure they are legible and visible.

I understand the County may treat the described areas with herbicide, *without prior notice*, if the weeds are not controlled or if the signs are not properly in place, readable, and clearly visible. I understand proper OWM sign placement is my sole responsibility.

I have been provided and understood the current "Baker County Weed List". I agree to all of the terms and conditions set forth in this contract.
